I'm sure by now you have been informed of my phone calls to both the Los Angeles, and the surface of the surfac

I hope that for all these years you have suffered the way that I have. For years I blamed myself, and to this day live with a tremendous amount of shame. Logically I know that I am not to blame, but logic really has no part in feelings sometimes. I was a little girl. You took that from me. Why?

A man who was supposed to be moral and right. First to have an affair with my mother, you remember her don't you REDACTED and then to violate me in the worst way imaginable. For years I have put it in the farthest part of my memory, trying to run from it and hoping that somehow it would just go away. But how do you make feeling like this disappear. It could be a something so small no one else would even notice, that make all those memories come right back into the forefront of my mind. I remember. I remember it all!!!!!!

It started when I was 5 or 6 and went on until I was almost 9. You lived in the same house with us, sleeping with my mother, while molesting me when she was gone at work. Sometimes even when she was just in the other room. I remember the house, the living room, the bathroom and mybedroom. All



those times you asked to dry me off after my bath, and told me to put on my nightgown without any panties underneath. I remember you coming into my bedroom after went to bed and asking me to kiss your "private area" or put it in my mouth, or touch it like a good girl. I remember your hands in my pants and in my shirt. I remember you groping me underneath the blanket on the couch. And I remember hiding underneath the living room table, pretending to be asleep so you would just leave me alone. I remember your words "your mother won't love you if you tell", "you like this don't you?". I remember the pain. Why??????????

And I remember you leaving to return to "your mother was sick". Yeah, what a great excuse to escape the repercussions of what you were doing. I remember listening to my mother on the phone with you, begging you to come back. I was so afraid that you would. And then she went to try to get you to come home. And I blamed her. I ran away, so afraid you would come back. Is that a way for an 8 year old child to have to live? In constant fear. Why?

I am now a 36-year-old woman trying to cope with knowing that for so long I did nothing to stop you. How many other children did you hurt? That is a question that burns in my heart. If I had the courage to speak up so many years ago, how many children could I have protected? But I have the courage now, and you will pay. I look at my own children and know that if this had been them, I would want whoever hurt them to pay. I would do whatever it took to ensure that, and I know I deserve that as well. I'm tired of being that scared little girl. I want you to be publicly shamed the way I have lived with the shame my entire life. I want your family, your community, your church, everyone to know the kind of man you are. I can't even call you a man, you are evil.

They tell me you are ill with the person that you are suffering. How ironic it is that you are suffering with the exact same illness my mother lied and said she had to get you to return. They protect you from my phone calls saying it isn't in your best interests at this time. Fuck you!!!!! You don't have any rights, you owe me. You owe me the chance to be able to put this to rest. You owe me whatever it takes to make me whole again. I'm asking for 10 minutes of your time, I think that is nothing compared to 30 years of hell. If I could, I would come to to force you to look at me, to see first hand the person that you hurt. Be a decent man for once in your life and tell them to



allow me to speak with you. I don't know if that will be enough, but it will be a start. It can be done very quietly or as loud as I need to make it to get what I am asking for. It's really your choice. A choice you don't even deserve to make.

Dear Cardinal Mahoney,

I am writing this letter to you to bring to your attention my current situation. I don't know if your office has been yet made aware of me, but I have spoken with REDACTED the Provincial of LA as well as REDACTED Provincial. Approximately 30 years ago, for a period of approximately 3 years, a Priest in your diocese REDACTED was involved in a relationship with my mother. During this time he was assigned to the state of the provincial approximately 3. He lived in our house and during this time assaulted me. (Please see attached copy of letter I mailed to him and gave to REDACTED on 5-16-02 detailing what occurred.

The actions I have taken thus far have all been done with the utmost privacy in order to protect my family as well as myself. All I asked for a simple phone call to get a chance to confront REDACTED a request that has been denied. I am now at a loss as to where to turn next. I have not yet gone to the media with the lack of assistance I have received, nor have I contacted an attorney to start the process of pressing charges. Both of these options were ones I was hoping to avoid, but now don't know what other alternative I have. I feel like I am batting my head against the wall. It seems that again the Church is more concerned with protecting the abuser than helping the victim. I didn't ask for this, but I am more than willing to finish it.

The chronology of what I have done so far is as follows.

- 1. May 7, 2002 Spoke with REDACTED @ the Los Angeles Provincials Office and asked for information on REDACTED She said she would research and call me back.
- 2. May 7, 2002 REDACTED left a message that he would be out of town until Thurs. 5/9/02.
- 3. May 9, 2002 My husband spoke with REDACTED and he provided us with info. (current location, Phone # to Provincial there and address to

- 4. May 10, 2002 Spoke with REDACTED in Gave him the general info and he said REDACTED would call to set a date to meet to take a formal statement. He would not allow me to speak with REDACTED ("not in his best interest at this time")
- 5. May 14, 2002 Still no response, called REDACTED office. He called back to schedule a time.
- 6. May 16, 2002 Met with REDACTED at my home to give statement. Gave him a copy of the enclosed letter to REDACTED He said he would fax it to REDACTED in Ireland.
- 7. May 16, 2002 REDACTED called to say REDACTED would be presented with the letter and an investigation would ensue. They would investigate there in Ireland and if necessary bring REDACTED back to California at the Churches expense and have an independent investigation done here in California.
- 8. May 18, 2002 REDACTED left a message that he just got back from Washington and no word yet. Said would call me back in a few day's
- 9. May 28, 2002 Had not yet received a call so I called and left a message to please call me.
 - 10. May 29, 2002 Still no word, I left another message in Ireland.
- 11. May 29, 2002 REDACTED :alled me back to tell me that REDACTED received the letter I had sent in the mail. (They had not yet presented him with the copy that they had had for over two weeks.) Something that I told would be done on May 16, 2002. during our conversation he told me about the denial and basically nothing was being done except REDACTED was seeking legal advice and I should get a letter from him in a few weeks.
- 12. June 4, 2002 Called and spoke with REDACTED he said would it was all in there hands.
- 13. June 4, 2002 REDACTED called me for to say that I would receive a letter in the mail from REDACTED with his response. Said the delay in getting the letter delivered to him was that they "feared he would drive his car off a bridge into the sea". When I asked why an "innocent" man would kill himself, they said he was "that sort of man". He also told me that basically the Church was not going to do anything about my allegations. No investigation, nothing. Basically he was just denying it and that was that. He also told me that California should be handling this and California told was to handle it. What is the truth? It seems the more I question, the more the answers change.

Now I have not choice but to seek my own legal counsel and file a legal suit against Fr. REDACTED as well as the Provincials in both Los Angeles I will also be contacting

the press to notify them of yet another cover up. Basically, I have been patted on the hand and told how sorry you all are this happened to me, but too bad. I need to know what your office intends to do about this. Please contact me upon receipt of this letter. I will be waiting for your call.

Given that REDACTED, is a member of your community residing in Italian, and that REDACTED resides in the same seems, the Cardinal realizes that he has no jurisdiction in this matter. Hopefully, your pastoral efforts to reach out to her will address her needs and contribute to the long process of her healing.

I would appreciate one piece of information. Her allegation concerns events some years ago., In this particular letter, she does not indicate where she and her mother lived at that time, or where REDACTED was stationed. Our records of priests belonging to religious congregations in that area were not well kept. Was REDACTED assigned to a ministry within the Archdiocese of Los Angeles when the alleged events took place? I would appreciate it if you would send me a listing of all the assignments in which he served within the Archdiocese of Los Angeles.

I am profoundly sorry that you suffered so terribly all these years. I pray that slowly but surely, with the help of God's grace, you will experience healing and peace.

Since REDACTED is a member of the Congregation of the Sacred Hearts, you appropriately contacted REDACTED the local provincial. Since religious communities govern themselves, and since REDACTED is not currently residing or ministering within the Archdiocese of Los Angeles, Cardinal Mahony does not have the power to investigate or intervene in response to your complaint. He has asked me, however, to provide you with information concerning those who do have authority to intervene in the matter.




